## STUDENT'S RIGHT TO CANCEL

A student may cancel enrollment by giving written notice to Montessori Stoppani. A student has the right to cancel and obtain a refund of charges paid through attendance at the first lecture session, or the seventh day after enrollment, whichever is later.

### **Termination after the Commencement of Classes**

If participation in the course is terminated after entering classes, the student is financially obligated to MSI according to the following formulas or maximum charges:
